

**ANNUAL SINGLE TOWNSHIP ROAD DISTRICT TAX LEVY ORDINANCE**

An ordinance levying taxes for the Elk Grove Township Road District, Cook County, State of Illinois.

The Highway Commissioner of the Elk Grove Township Road Township District on November 24, 2008, does hereby determine and declare that the amount of money necessary to be raised by taxation and levied for Road purposes for said District is as follows:




And it is hereby directed that the aforesaid sum be raised by taxation in the manner provided by law.


