- I. <u>Call to Order.</u> Supervisor Busse called the meeting to order at 7:00 pm, which was followed by the Pledge of Allegiance to the Flag.
- II. <u>Roll Call.</u> Present: Trustees Niewiardowski, Keenley, Wojtecki, Dante, Supervisor Busse. Also in attendance: Assessor Carosielli, Administrator Pioch
- III. Public Comment. None
- IV. <u>Consent Agenda.</u> Supervisor Busse asked for a motion to approve the authorization of payroll and bills and to approve the Supervisor's Report consisting of information regarding Social Services, Employment Support, Food Pantry, Youth Services, Adult and Family Counseling, Transportation Services and Financials.  - 1. Remediation There are some potential issues with the requirements of the NFR apparently not followed by the village. This may hold up the construction of the courses. We are working with our consultant to gather information and do testing.
 - 2. Ropollo Dr. We are meeting with the new village manager this week to discuss the plan, and a plowing proposal, and get approval to lower the speed limit. Then we'll meet with the residents and Elk Grove Village, and then institute the plan.
 - 3. Mount Prospect Plowing We met today with the village manager and the public works manager to discuss a plowing proposal, a TIF District and Rural Fire Department and Plowing IGA.
 - 4. Ray Rummel There is a retirement reception for the Elk Grove Village outgoing village manager on March 31. It would be good to have some trustees attend.
 - 5. Community Empowerment Fund We are getting the vote from the board of the fund on the new bylaws. Then we will restructure the committee and add two trustees.
 - 6. Holiday Party will be this Friday; we have a good turnout.
