#### Minutes

- I. <u>Call to Order Supervisor Busse called the meeting to order at 7:00 pm, which was followed by the Pledge of Allegiance to the Flag.</u>
- II. <u>Roll Call</u> Supervisor Busse, Trustees Niewiardowski, Keenley, Maye, Perns. Also in attendance: Administrator Pioch, Assessor Carosielli.
- III. Public Comment None
- IV. Consent Agenda
  - A. Authorization for Payroll/Bills Town Fund, General Assistance, Road Department & Sewer
  - B. Supervisor Social Services, Employment Center, Food Pantry, Adult & Family Counseling, Transportation & Financial
  - A Motion to approve the Consent Agenda was made by Trustee Niewiardowski and seconded by Trustee Keenley. *The Motion passed on a 4-0 roll call vote with one abstention*.
- V. Discussion and Potential Action on Approval of Minutes
  - A. April 17, 2023 Regular Board Meeting
  - A Motion to approve the Minutes was made by Trustee Keenley and seconded by Trustee Niewiardowski. *The Motion passed on a 4-0 roll call vote with one abstention.*
- VI. Reports: Acceptance of Township Elected Officials' Monthly Reports
  - A. Assessor Carosielli The Assessor provided a written report and shared a letter of appreciation for excellent service from a resident. She stated that the deadline for exemptions has been extended until August which means that the 2<sup>nd</sup> installment tax bills will be late again.
  - B. Clerk Satern The Clerk provided a written report with one FOIA request.
  - C. Supervisor Busse The Supervisor shared the following updates:
    - 1. Remediation on the property we will be filing remediation documentation with the county. Then the NFR will be official.
    - 2. Construction the bathrooms and bike safety room are completed. The demolition and fences are completed and construction on the courses is starting. We may use the bike safety room for youth programming and the side room for storage and store the bikes in the highway department area.

- 3. Hiring we are still working on hiring another therapist and will be hiring a part time bike safety director. We hired a receptionist for the front office, Ewelina Radzik, who will be cross trained in other areas.
- 4. Community Services day the biannual event was well attended. We will have a shredding event and a flu shot event in the future.
- 5. Ropollo Dr. signage we are holding off on the signage due to the sale of the homes to a real estate developer.
- 6. Decennial Committee we are required to have the first meeting by June 10. All the trustees will be on the committee and we will have 4 subcommittees. It will be an 18 month process.
- 7. Assessor issue in Schaumburg Township we had a discussion of the issue of CAIO training and cost, and appointment of assessors.

A Motion to approve the monthly reports of the elected officials was made by Trustee Maye and seconded by Trustee Keenley. *The Motion passed on a 5-0 roll call vote*.

- B. Transfers of Appropriation Town Fund & Social Services A Motion to approve the Transfers of Appropriation was made by Trustee Niewiardowski and seconded by Trustee Keenley. *The Motion passed on a 5-0 roll call vote.*
- C. 2022-2023 Tentative Budget Town Fund/Social Services/Sewer-AMENDED A Motion to approve the Amended budget was made by Trustee Maye and seconded by Trustee Niewiardowski. *The Motion passed on a 5-0 roll call vote*.
- D. 2022-2023 Tentative Budget Road Department-AMENDED A Motion to approve the Amended budget was made by Trustee Niewiardowski and seconded by Trustee Maye. *The Motion passed on a 5-0 roll call vote*. There needs to be a 30 day waiting period on the amended budgets, and then there will be a Public Hearing on the budgets preceding the next board meeting in June.
