Minutes

- I. <u>Call to Order</u>. Supervisor Busse called the meeting to order at 7:00 p.m., which was followed by the Pledge of Allegiance to the Flag.
- II. <u>Roll Call.</u> Present: Trustees Niewiardowski, Keenley, Wojtecki, Dante and Supervisor Busse. In attendance: Administrator Pioch, Assessor Carosielli, outgoing Supervisor Sweeney, outgoing Highway Commissioner Niewiardowski, and outgoing Trustee Ingraffia.
- III. Public Comment. None
- IV. <u>Consent Agenda</u>. Supervisor Busse asked for a motion to approve the authorization of the payroll and bills and to approve the Supervisor's report consisting of information regarding General Assistance, Employment Support, Food Pantry, Transportation Services and Financials, and Resolution #2021-04 for Supervisor Sweeney, Resolution #2021-05 for Trustee Ingraffia and Resolution #2021-06 for Highway Commissioner Niewiardowski. A motion to approve was made by Trustee Niewiardowski and seconded by Trustee Keenley. *The motion passed on a 5-0 roll call vote.*

Supervisor Busse read and presented the Resolutions to outgoing Highway Commissioner Niewiardowski, outgoing Trustee Ingraffia and outgoing Supervisor Sweeney. Trustee Keenley presented outgoing Supervisor Sweeney with a gavel plaque from the Board of Trustees. Administrator Pioch presented outgoing Supervisor Sweeney with a "King of Symmetry" plaque recognizing his intense commitment to symmetry in the new township building project.

VII. <u>Elected Official Reports.</u>

- A. <u>Assessor's Report</u>. Assessor Carosielli submitted a written report. She also reported that in the last 30 days her department has filed 1400 permits that they have been waiting to input into the county's online system. Also, the EGT Assessor's office and two other townships are sponsoring a Board of Review Zoom Outreach Program on Monday, June 8 on "How to Successfully File an Assessed Value Complaint." Residents need to call the Assessor's Office to register.
- B. <u>Clerk's Report</u>. Clerk Satern submitted a written report. She also noted that our elected officials that were elected for the first time need to complete Open Meetings Act Training through the Illinois Attorney General's website. The website is currently down and Clerk Satern will notify the new trustees when it is back up. Also, all elected officials need to take Sexual Harassment training annually. Paul will send the link to the online training to all of the elected officials.
- C. <u>Supervisor's Report</u>. Clerk Busse reported that we are still in discussions with Elk Grove Village regarding the remediation of the north side of our property. As soon as we receive a NFR (No Further Remediation) we can start on the Bike Safety and Challenge Course projects. He reported that he has been meeting with the township department heads, discussing operational issues and other updates.
