## **MINUTES**

- I. Call to Order: Supervisor Sweeney called the meeting to order at 7:00 p.m.
- II. <u>Roll Call:</u> Trustees Koshaba, Satern, Niewiardowski, Ingraffia & Supervisor Sweeney Present. In Attendance: Deputy Clerk/Administrator Pioch, Assessor Carosielli & Highway Commissioner Niewiardowski
- III. Public Comment: None
- IV. Proposed RFP to Audit Firms for Elk Grove Township Fiscal Year 2018-2019: Supervisor Sweeney advised that the reason for this RFP was to start in motion the process to solicit proposals from new Audit firms so a new firm could be engaged to perform next year's audit. A motion was made by Trustee Koshaba and seconded by Trustee Niewiardowski to Table the item until the September 25, 2017 Board Meeting.
- V. <u>Authorization for Payroll & Bills Town Fund, General Assistance, Road District and Sewer:</u> A motion was made by Trustee Ingraffia and seconded by Supervisor Sweeney to remove check # 69839 (reimbursement to Trustee Koshaba for the purchase of 7 Laws & Duties Handbooks) so it could be considered separately from the remainder of the bills and payroll. Golf Road and potential litigation regarding the property. A motion was made by Trustee Koshaba and seconded by Trustee Ingraffia. The motion passed by voice vote at 7:12 p.m.
