  passed some regulations for travel, which adds some legal language that affects
  local government and control act. Motion to approve the Ordinance was moved by
  Trustee Ingraffia and seconded by Trustee Niewiardowski. Motion was carried by
  voice vote.
- 3. Resolution 2016-07 Authorizing the Sale of Township Real Estate This document needs to be approved for the purpose of adopting the actions that were approved by the Electors at the Special Township Meeting held last Monday, November 21, 2016 to put 401 W Golf Rd on the market for bid in order to receive potential offers.   - 10. Selling the property in an "as is" and "with all faults" conditions
  - 11. Bid opening will occur at the Monthly Township Board of Trustees Meeting February 27, 2017
  - 12. Sale is subject to the terms and conditions of a real estate agreement, will discuss as we enter a contract by accepting a bid
  - 13. Recognizing that the electors authorize us as the board of Elk Grove Township, proceeding and carrying out the attempt of the resolution
  - 14. The Supervisor and Clerk are authorized and directed execute and any documents pertained to the sale
  - 15. This resolution was approved by the majority of the electors at attendance at special meeting November 21<sup>st</sup>, 2016, by a voter 40 aye votes and 26 nay votes
  - 16. This resolution acknowledges and adopted to state the intent the electors to sell at its regular board meeting November 28<sup>th</sup>, 2016 at 7pm. No questions.
