# TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES ELK GROVE TOWNSHIP ROAD DISTRICT

I, the undersigned, hereby certify that I am the presiding officer of, Elk Grove

Township, and as such presiding officer I certify that the levy ordinance, a copy of
which is attached, was adopted pursuant to, and in all respects in compliance with
the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.
