ANNUAL SINGLE TOWNSHIP ROAD DISTRICT TAX LEVY ORDINANCE

An Ordinance levying taxes for the Elk Grove Township, Cook County, State of Illinois, for the tax year 2020, collectible in 2021.

The Highway Commissioner of the Elk Grove Road District on November 23rd, 2020 does hereby determine and declare that the amount of money necessary to be raised by taxation and levied for Road purposes for said District is as follows:



**TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES
ELK GROVE TOWNSHIP ROAD DISTRICT**


I, the undersigned, hereby certify that I am the presiding officer of, Elk Grove Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- X 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
