### ANNUAL SINGLE TOWNSHIP ROAD DISTRICT TAX LEVY ORDINANCE

An Ordinance levying taxes for the Elk Grove Township, Cook County, State of Illinois, for the tax year 2022, collectible in 2023.

The Supervisor of the Elk Grove Township Road Department on September 27, 2022 does hereby determine and declare that the amount of money necessary to be raised by taxation and levied for Road purposes for said Road Department is as follows:


**TRUTH IN TAXATION  
CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES  
ELK GROVE TOWNSHIP ROAD DISTRICT**

I, the undersigned, hereby certify that I am the presiding officer of, Elk Grove Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- X 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.


