ASSESSING THE SITUATION

Now is the time to make sure your exemptions are in place before the second installment tax bills are issued.

Do you qualify for any of the following?

- Homeowners-your principal residence for the year in question
- Senior Citizen-born in 1952 or before & primary residence
- Senior Freeze-born in 1952 or before & total household income \$65,000 or less.
- Returning Veterans' Homeowners-veteran returning from active duty from an armed conflict
- Disabled Veterans Homeowner-call for qualifications and requirements
- Disabled Persons Exemption-call for qualifications and requirements

We will be happy to answer your questions and help you file for what you qualify for. Exemptions appear on the second installment tax bill.

We have been informed that we are now open for assessed value appeals to the Cook County Assessors' office, closing on April 23rd. If you believe you are over-assessed, we will assist you in researching comparable properties and submitting the appeal.

If you are on the Senior Freeze, you don't need to appeal.

There will be a taxpayer seminar, with a guest speaker from the Assessor's office on Monday, April 16th at 6:30 pm in the Elk Grove Township Hall, 2400 S. Arlington Heights Rd. sponsored by Senator Laura Murphy, Commissioner Tim Schneider, State Reps. Marty Moylan & David Harris. Register Now for the November

Election. An important gubernatorial election will take place this fall. Given the financial morass in which the State currently finds itself, I want to strongly encourage all eligible Township residents to register to vote! Remember to be eligible to vote you must be a U.S. citizen, be at least 18 years of age, and be registered. There are three ways in which you can register to vote:

- **Online Voter Registration:** Complete the online application found on the Illinois State Board of Elections website <https://ova.elections.il.gov>. You must have a valid driver's license or State ID to complete the application.
- **In person with a certified registrar:**
 - At one of the Cook County Clerk's six locations. Go to <https://www.cookcountyclerk.com/locations>
 - At a municipal or Township Clerk Office
 - At an Illinois Secretary of State driver's license facility
- **Mail Voter Registration:** Complete a mail-in voter registration application form and return it to the Cook County Clerk's office. Voter registration forms are available at the Elk Grove Township office.

2018 Illinois Fishing Licenses. Let's put the politics aside for a little while and focus on something fun! Summer is right around the corner and fishing rods and reels will soon be coming out of storage. Elk Grove Township is blessed with one of the best fishing spots in Cook County. The three Busse Reservoirs (Main, North and South) offer a combined 457 acres of prime fishing. The lakes are stocked with northern pike, walleye, bass, crappie, perch and bluegill. The Main Reservoir is also the only fishing area in Cook County with the king of fresh water fishing – the Muskie! The Busse Reservoirs have fishing walls and boat rentals (electrical motors). Personal canoes, kayaks, rowboats and sailboats are permitted. However, before you drop your line in the water make sure you have a 2018 Illinois Fishing License. There are several types of licenses available but the most commonly purchased are Illinois Resident Daily for \$5.50, Illinois Resident Annual for \$15.00 and Illinois Resident Senior (65 and older) for \$7.75. **Fishing Licenses can be purchased at the Township office Monday through Friday 9:00 a.m. to 4:00 p.m.** Pick up a license and start preparing your story about the big one that got away!

News from your Highway Commissioner

Branch Pick-Up Reminder:

• Branch pick-up is offered from April through October weather permitting, on the fifteenth of each month. If the fifteenth falls on a holiday or weekend, branch pick-up will be scheduled for the first work day which follows.

- Branches are picked up in residential areas on the streets maintained by the Township ONLY (unincorporated areas).
- We ask you to limit your piles to storm and wind damaged branches and not to exceed two cubic yards. If a landscaping or tree service takes down a tree on your property, they are responsible for its disposal. Please also remember your waste disposal company will pick up branches that are bundled and tied.

What will be picked up?

- Branches with a minimum of 2 feet in length and a maximum of 12 feet in length and less than 6 inches in diameter.

What will NOT be picked up?

- Small hedge or pine clippings
- Yard waste or brush in containers
- Brush or branches with thorns
- Stumps or tree roots

How to stack the brush:

- Neatly stack the branches in one direction with the butt end toward the street.
- No lumber, wire, rope, or other material may be included with branches.
- Remember, once we have gone through an area, we will not return until the next scheduled date.

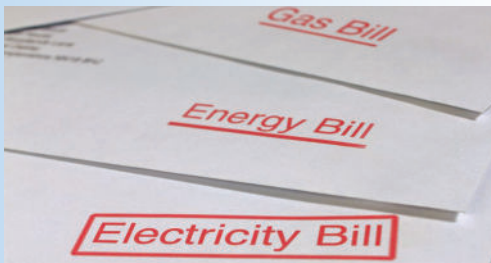
Last chance for LIHEAP (Low Income Home Energy Assistance Program)

The LIHEAP (Low Income Home Energy Assistance Program) ends on May 31, 2018, or sooner if funds are exhausted. The program is open to all that have proof of qualifying family income, social security cards, and their recent utility bills.

At that time, we will do a pre-screening and give you instructions as to the documentation that you will need at the time of application.

Nicor Sharing/Gas Bill Relief Program

The Nicor Gas Sharing Program may be available to those over income for LIHEAP. The program offers a one-time annual grant, with **no** requirement to be paid back, to qualified residential customers who meet the required income guidelines. Nicor Sharing Program is funded through direct contributions from Nicor Gas' customers and employees. If you're approved for a Sharing Grant, the Salvation Army will make payments to Nicor Gas on your behalf. Customers can receive a Sharing Grant of up to \$450 and special programs are designed for veterans and customers in crisis situations.

Highway Department:

The role of the Highway Department is the care and maintenance of the roads in the unincorporated parts of Elk Grove Township. This includes repair and snow removal.

In addition to the road maintenance, the Highway Department also does brush pick up twice a year for residents of the unincorporated areas of the township.

Transportation Services:

Dial a ride: Senior residents of Elk Grove Township age 55 and older may use the DIAL-A-RIDE services. All buses are handicap accessible (i.e. walkers, wheelchairs, etc.).

T.R.I.P.: This program is the Northwest Suburban Cook County Inter-township Transportation for medical purposes for Senior Citizens and Persons with Disabilities.

Disability Transport Services: This program is our discounted cab service. Seniors 55 and older and people with permanent disabilities over the age of 18 are eligible.

Bike Safety: Bicycle Safety is provided by Elk Grove Township to all students of our Township. The program is funded by the taxpayers that live in our township, and has been in existence for almost 30 years.

Social Skills, Girls Empowerment, Transitions Groups. Summer Sign-Ups Begin!

Summer is just around the corner, and it is not too soon to think about the needs of your child, and how they might benefit from various groups offered by the Youth and Family Services' Challenge Program during the summer.

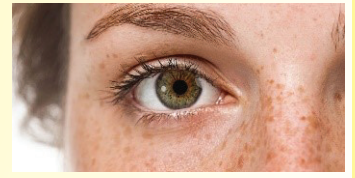
Our **"SuperStars"** groups are designed for kids aged 7-12 who struggle with social skills. The group teaches children how to recognize social cues of other children, and how their own behavior impacts others. The program uses outdoor activities and our Teams Course to create "real life" examples for learning. The **SuperStars** program meets one time per week (2 hours), and lasts for 6 weeks. Cost for the entire program is \$60.00.

Our **"Girl Power"** groups also use outdoor and Teams Course activities, and is designed to empower girls (7 to 13) to feel more control over their lives by providing them with tools for handling peer pressure, improving wellness, and becoming a positive role model for others. Groups meet one time per week (2 hours) and costs \$60.00 for entire program.

The **"Transition to Junior High School Group"** is offered for students who might have difficulties with the transition to Junior High. Participants will explore realistic expectations of this transition; both socially and academically. Students will learn strategies and experience the "power of the group" to support one another for a positive experience with the transition. Groups meet one time per week (2 hours) and costs \$60.00.

Eye on Credit!



Your credit score is an integral factor in determining loan approval and qualified interest rate. The better your credit score the better interest rate and programs you will qualify for. On a home purchase loan the minimum acceptable middle FICO score is 580 however, some lenders/banks require 620+ for loan approval to buy a home. Minimum credit score approval varies according to each lending institution's guidelines.

The good thing about credit scores is that they can be improved prior to a home purchase. Buying a home is a major financial decision and obligation. Maybe one of the biggest financial decisions and obligation that you will make in your lifetime. Although a 580 credit score will get you approved for a home loan with some lenders. Having a 620+ score will qualify you for better interest rates and other loan programs. The better your credit score the better your options will be.

Here are some of the best ways to build your credit score:

- Make payments, including rent, credit cards and car loans, on time
- Keep your spending to no more than 30% of your limit on credit cards
- Pay down high-balance credit cards and consider balance transfers to free up credit.
- Check for any errors on your credit report and work toward fixing them.
- Shop for mortgage rates within a 30-day period. Too many spread-out inquiries can lower your score.

Be a Safe Bike Rider

Bike riding season is almost here so put down those electronic devices and go outside and ride a bike!

There are so many great reasons to ride your bike:

It offers fun, freedom and exercise.

Here are a few bike safety tips to help make biking more fun:

- Wear a properly-fitted helmet
- Ride in the same direction as traffic, as far on the right-hand side as possible
- Use hand signals and follow the rules of the road
- Wear bright colors and use lights
- Parents, ride with your children
- Properly-fitted helmets can reduce the risk of head injuries by at least 45 percent
- More children ages 5 to 14 are seen in the ER for injuries related to biking than any other sport

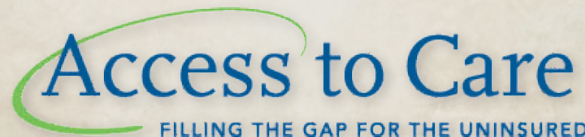
