A Message from the Supervisor...

Even though I grew up in Mount Prospect I have never really gotten use to our cold winters. I am always glad when spring and summer are right around the corner. You can have the snowmobiling, ice fishing and ice skating. That said, it doesn't matter the season, we at the Township are always working hard to meet the needs our residents.

Demand for Services Continues to Grow

The Township has had a very active start to the year. The number of residents seeking social service assistance and adult & family counseling is up dramatically. Food Pantry visits are now exceeding 600 families a month. Senior services are significantly expanding with the addition of an Older Adult Programming and Benefits Specialist while usage of our Senior & Disabled bus service remains high. Of special note, the Assessor's office has been deluged with residents seeking help with property tax appeals and exemptions. With County property taxes constantly on the rise our Assessors staff have become superstars for the many Township residents seeking help with their growing tax burden.

Mental Health Assistance Moving to the Forefront

I would like to take a moment to address one area of particular concern – mental health growing concern and township attention. Our Clinical Director, Luanne Pross, has observed a significant increase in the number of individuals struggling with anxiety, depression, and other mental health issues over the last several years. Luanne believes that COVID, social media, and financial uncertainty are some of the more significant factors driving this emerging crisis. She is especially concerned about the increase in mental health problems occurring among adolescents and children. Luanne points out that mental health visits to emergency rooms by adolescents and children jumped 31% in 2020 and that this trend has shown few signs of slowing down.

Elk Grove Township is unique compared to most other Illinois townships in that it offers no cost mental health counseling services for its residents. Clients of all ages can be seen by licensed therapists, including bilingual Spanish speaking counselors, who can help address a wide range of mental health needs including anxiety, depression, addiction, family/relationship issues, and behavioral problems.

The Township counseling process begins with an intake appointment over the phone. A staff member asks questions to identify specific mental health needs. If the needs can be met by Township therapists, an in-person assessment is completed at the Township offices and counseling sessions are scheduled. If the needs are more specialized or psychiatric in nature, referrals can be made to Township agency partners such as Kenneth Young, Children's Advocacy Center, and Wings. A valuable, new partnership the Township has established is with the Josselyn Center. The Josselyn Center provides psychiatric services and is able to serve residents in need of medication.

I am pleased to say again that all Township mental health services are offered free of charge to residents and are totally confidential. To learn more, please call us at 847-981-0373 or visit ElkGroveTownship.com

Keep in mind, the Homeowner and Senior exemptions automatically renew. Those of you that have purchased new or pre-existing homes should double check the exemptions that have been applied to your property. This assessed value and characteristic verification is easy to accomplish. You can go onto the Cook County Assessor's website or call our office; we would be happy to do this for you.



Here is a list of the costs of 2023 Illinois Fishing Licenses. Make sure and stop by and get your license before you head out to fish.

- Illinois Resident Daily fee: \$5.50
- Illinois Resident Annual fee: \$15.00
- Illinois Resident Senior (65+) fee: \$7.75

Fishing licenses are not required for people under age 16, the blind and disabled, or active-duty military. Just be sure to have the current appropriate ID with you.

The Elk Grove Township Food Pantry is now open 4 days a week! Pantry shoppers can now visit the pantry on Fridays from 9:30 a.m. to 3:30 p.m. in addition to Tuesdays from 9:30 a.m. to 7:00 p.m. and Wednesdays/Thursdays from 9:30 a.m. to 3:30 p.m. The Elk Grove Township Food Pantry offers food pantry visits by appointment ONLY and all you need is a valid food pantry card. To schedule an appointment please call 224.265.6111. If you are a new client, please arrive at least 15 minutes early and bring with you a current utility bill (dated within 30 days) and photo ID.



The Pantry offers a wide variety of dry goods as well as fresh produce, dairy and meat products, household items, and personal essential items. Families of four(4) or more are encouraged to use the pantry the maximum number of allotted visits (2 per calendar month) to ensure an ample amount of food and household items are available to you.

Senior Health Insurance Program

Time is running out to apply for utility benefits

If your household's gross income has fallen below the 250% Federal Poverty Level in the last 30 days you are entitled to assistance towards your gas, electric and water bills. Appointments are limited and the program ends May 31. Not sure if you qualify? Give us a call and we can screen you for eligibility.

Medical Lending Closet

If you are in need of medical equipment such as wheelchairs, walkers, canes, crutches, or other items, the Township can help! We lend these items to residents at no cost at increments of three (3) months. Availability varies so call to find out more.




Mental Health Counseling Services 847-981-0373

Youth Services

Much of what children fear is rooted more in imagination than in reality. Parents may be called upon to ease anxieties about everything from strange noises to water, from spiders in the yard to monsters under the bed. Comforting children seized with irrational fears can be a difficult task.

Tamar E. Chansky, a psychotherapist who treats anxious children and adults and wrote a practical guide, "Freeing Your Child From Anxiety," said the goal was not to put down children's fears but to help them see that their fears are unwarranted and that they can overcome them. She has created a "master plan" for helping children gain control over their anxiety:

- Empathize with your child. Resist the temptation to tell the child there is nothing to worry about, and instead, acknowledge the child's concerns and the effect they have.
- Describe the problem as coming from "the worry brain" that jumps to conclusions and cannot be trusted. Give worry a name, like "brain bug." This takes the focus from the child's particular fear and makes anxiety itself the problem.
- Rewire and resist. Ask your child what they are really worried about and what they think might happen. Then ask them to check whether these thoughts really make sense. Help them find inner strength, the voice that tells worry it is not the boss.
- Teach relaxation techniques to temper the biological alarm to fight or flee whenever fear takes over.
- Help the child focus on what they want to do and what they would do if worry was not in charge.
- Finally, reinforce your child's efforts, praising them for getting through a tough situation.

For those in need of professional help, between 10 and 20 sessions of C.B.T (Cognitive Behavioral Therapy) can produce "meaningful clinical improvements in 50 to 70 percent of children," Dr. Golda S. Ginsburg, PHD said. "Anxiety is a chronic illness that can emerge in times of environmental crises or change," she said. "Prevention is important. I want parents to be proactive rather than reactive. A minor adjustment can prevent re-emerging anxiety from interfering with child's life"

Coping with a Family Member's Addiction

Most of us know someone in our families who has struggled with a drug or alcohol addiction. According to the National Center for Drug Abuse, data from 2020 reveals:

- 13.5% of Americans 12 and over used drugs in the last month.
- 21.4% of people 12 and over have used illegal drugs or misused prescription drugs within the last year.
- 20.4% of Americans have an alcohol use disorder.
- 57.277 million people use tobacco or nicotine products (vape).
- 25.4% of illegal drug users have a drug disorder.
- 24.7% of those with drug disorders have an opioid disorder; this includes prescription pain relievers or “pain killers” and heroin.

The numbers are growing with more recent legislation legalizing some drugs of abuse and increased accessibility by youth.

Addiction problems range from mild to moderate to severe and pose significant consequences to not only the person struggling, but also to family members. The impact can be devastating emotionally, financially, legally, and can even lead to mental health problems and stress related medical issues for loved ones.

When someone's substance use becomes problematic, family relationships are often the first area of life affected causing mistrust, anger, shame, insecurity, and arguments. The person abusing the substance is usually in denial that their use is excessive even though their family members are hurting. The user usually dismisses their hurt to avoid having to face the issue challenge of evaluating their substance use.

How can family members cope with a loved one who has an addiction problem but refuses to seek help?

Recognizing and *accepting* the reality of the substance problem is the first step and perhaps most difficult. It is normal to minimize or excuse excessive use, however as it becomes more frequent, *educating* oneself and other family members about the problem will assist in developing a coping plan.

Seeking support from others such as close friends, teachers, and other family members can also help and/or joining a more formal in-person or on-line support groups such as Al-Anon or Families Anonymous to work through the tendency feel overly responsible or shame about the ways the addiction problem has been progressing. *Confiding* in your priest, pastor, or spiritual mentor can be of great help.



Engaging a professional counselor with a background in helping family members of those with alcohol or other substance related disorders is another strategy to navigate a path towards recovery for your family.

Most importantly, family members should never blame themselves for a person's compulsive use of a substance or other addictions.






