Assessing the Situation

As we begin 2020, my staff and I wish you good health and happiness for you and your families. It is important to take stock at this time of year to make sure that you file for all of the property tax exemptions that you are entitled to.



- Homestead Exemption (also known as Homeowner's <u>Exemption</u>)-You must have purchased and occupied your principle residence prior to January 1, 2019. This exemption reduces your assessed value by \$10,000 times the tax rate.
- Senior Citizen Exemption-You must be 65 years of age or older and living in your primary residence. This exemption reduces your assessed value by \$8,000 times the tax rate. If you have had the Senior Exemption in the past year you do not need to reapply, as the law has changed. The exemption now automatically renews. If you want to verify that your Senior Exemption is in place, simply call or come into our office.
- <u>Senior Freeze Exemption-</u> You must be 65 year of age or older with a total household income of \$65,000 or less. This exemption must be applied for every year, it does not automatically renew. To apply for a renewal, bring your 2018 Federal Income Tax return and my staff will assist you in filing. If you haven't qualified in the past, please bring in your 2018 tax return, ID and your last property tax bill. The forms for this exemption should be available in early January.
- <u>Disabled Person Exemption-</u>This exemption is valued at \$2,000 time the tax rate. Please call to learn what documents you need to apply.
- <u>Disabled Veteran Exemption-</u>If you are a veteran and 30-49% disabled, \$2,500 times the tax rate is available to you.
- If you are 50-69% disabled, \$5,000 times the tax rate is available to you.
- If you are 70% or more disabled, you will no longer pay a property tax bill. If this is an exemption you might qualify for, call or come into the office to learn the documentation you need to have for filing. Also, you will learn all of the benefits of this exemption.

Although this is not a triennial reassessment year, you need to be aware that you will still have two opportunities to appeal your assessed value. The first with the Cook County Assessor's Office, and the second is with the Cook County Board of Review. If you are not on our phone or email list, it would be in your best interest to share that information with us so that we can keep you informed regarding appeal windows and outreach programs.

My staff and I look forward to our new location. We have also embraced the newest technology to ensure that we provide you the best service and continue to be your taxpayer advocate.

News from your Highway Commissioner

As we approach the end of the 2019–2020 snow season, the Elk Grove Township Highway Department is well prepared for anything that Mother Nature might bring. We have a



commitment to maintain Township roads and keep them free from ice and snow.

Please remember to check and be sure that drainage areas and culverts are free of any debris that might reduce the drainage of melting snow near other property owners' areas. This will help the flow of melting snow, and will help reduce flooding.

Lastly, please do not discharge any snow from private areas onto any streets. This practice is not only inconsiderate to our neighbors and the general public, but is also illegal. In the past, Cook County Sherriff 's Police have been aggressively monitoring and cracking down on such violators.

Clerks Corner

The framers of the Constitution chose population to be the basis for sharing political power, not wealth or land. "Representatives and direct taxes shall be apportioned among several States which may be included with this Union according to



their respective numbers...." Article 1, Section 2. Every ten years a census is conducted that aims to count the entire population of the United States and gathers key information about them.

The census information is used for multiple purposes. First and foremost, the census count will determine the number of seats for each state in the House of Representatives. If a State loses population or is undercounted it will lose seats to other States that record an increase in population. Second, state and local officials use the census count to redraw boundaries for congressional districts, state legislative districts, school and other districts. An improper census count produces poorly drawn and, possibly, poorly represented/funded districts. Third, many federal programs use census information to help direct funding decisions. The census results will help determine how more than \$675 billion in federal funding will be allocated to states and communities. Incomplete census data could mean less money for your local schools, hospitals, roads and other public services. Fourth, state and local government use the census information for decisions concerning public services, public safety, and other public programs. Without proper information, services and programs in your community could be reduced or eliminated. Finally, fifth, businesses often use the census data to decide where to situate their offices, stores, and factories. Developers use the data to decide where to build homes and apartments. New businesses and homes usually bring jobs and higher incomes. In short, the information gathered through the census will directly impact you and your community in multiple ways. There is every reason to fully participate in the census in order to ensure that our communities receive the representation and funding that we deserve.

Census Day will be observed nationwide on April 1st. By this date, all households should have received a request to participate in the census. There will be three options for responding to the request: online, by phone or by mail. Note that the information collected by the census can only be used for statistical purposes. It is against the law for the Census Bureau to publically release or share your responses in any way that could identify you or anyone in your household.




One of the benefits of our move to a new facility is that we are now shifting from pre-packed bags of groceries to a Client Choice model. Here's more information about what you can expect about our new 2,400 square ft. food pantry!

What is a Client Choice Pantry? A Client Choice Pantry allows clients to select their own food instead of receiving a prepacked or a standard bag of groceries. With this method, clients do not have to take items they already have, do not like, or cannot eat for health or personal reasons. In our new pantry, clients will "shop" from an array for shelf-stable items, meats, dairy, and fresh produce.

Why give clients a choice? Some of the benefits of Choice Pantries are:

- Limit food waste customers take food they will use and leave the rest for others
- Save money for the pantry
- Make ordering easier pantries know what popular food to stock

IMPORTANT Energy Bill Assistance

Elk Grove Township is an application site for the LIHEAP program, please see program details below.

Direct Vendor Payment (DVP) and Reconnection

Assistance (RA) is designed to assist income-eligible households with energy services, in the form of a one-time benefit payment to the utility companies that is applied directly to the household's energy bills. The amount of the payment is determined by income, household size, and fuel type. RA is used to prevent or reconnect disconnected households.

We will be happy to pre-screen you, set up your appointment, and give you a list of documents necessary for application. Please note, in order to give our full attention to each client we cannot accept walk-ins.

Gas Bill Relief

The Nicor Gas Sharing Program may be available to those over income for LIHEAP. The



program offers a one-time annual grant, with **no** requirement to be paid back, to qualified residential customers who meet the required income guidelines. Nicor Sharing program is through direct contributions from Nicor Gas' customers and employees. If you're approved for a Sharing Grant, the Salvation Army will make payments to Nicor Gas on your behalf. Customers can receive a Sharing Grant of up to \$450 and special programs are designed for veterans and customers in crisis situations. Call our Social Services office for more information.

Mobile Dental Clinic



There is an undeniable link between overall health and oral health. Studies show that poor oral health may be linked to heart disease,

stroke, pre-term childbirth and oral cancer.

The Mobile Dental Clinic program provides preventive and restorative oral health services to individuals and families who are without dental insurance and who live at less than 200 percent of the federal poverty level. The program emphasizes the importance of overall oral health and establishing a permanent dental home. Staff includes a full-time dentist, program manager and dental assistant.

Elk Grove Township residents are screened by the township's Social Services staff to determine eligibility for treatment. A \$30 co-pay is charged for each adult appointment and there is no co-pay for children. 

Marijuana is Now Legal: What Parents Should Know

From the Adult and Family Counseling "Parenting Tool Box."

As most of you know, on January 1st recreational marijuana (cannabis) became legal for adults over 21 to purchase and consume in Illinois. This new environment may present a more complex set of challenges for parents who are trying to raise their children to make healthy choices, while worrying about the "mixed message" that legalization may send to them.



So, let's take a moment to clarify what has, and what has NOT changed.

- 1) Marijuana is still ILLEGAL for young people up to age 21, and there are consequences for violating possession/use laws, just as with any other violation of the law.
- 2) Marijuana use does impact performance: impairing short-term memory, attention, and problem-solving.
- 3) Marijuana can impair the safe operation of a motorized vehicle.
- 4) Marijuana use can permanently impair brain functioning if used during adolescence (the human brain is still developing until the early 20's, and research is showing long term effects for adolescent use).
- 5) Talking about marijuana with your children does NOT lead to them using.
- 6) Parental marijuana use in front of kids is associated with risk of use by their children.

So, all of the above have NOT changed. The only thing that has changed is that adults (over 21) can legally purchase small quantities of marijuana, and use it in the privacy of their homes.

The best advice for parents, therefore, is to talk with your children about marijuana—not in a "preachy" way but in a conversation, where you "listen," and give them a chance to share what they think about it. Of course, you should feel free to express your concerns about marijuana use (not unlike alcohol use), and even share the concern about the effects of use on current performance, safety, and long-term brain development. And, as with other expectations, set clear boundaries around substance use: rules and consequences. Even be open to asking for a commitment to call for a ride if impaired (you don't get out of some consequence, but you are SAFE).


