2021 Illinois Fishing Licenses

Since it's fishing season, and we are so close to Busse Woods and the great fishing there, here is a list of the cost of 2021 Illinois Fishing Licenses. Stop by and get your license here before you head out to fish! The three reservoirs at Busse Woods are stocked with a great variety of fish for you.

- Illinois Resident Daily fee: \$5.50
- Illinois Resident Annual fee: \$15.00
- Illinois Resident Senior (65+) fee: \$ 7.50

Fishing licenses are not required for people under age 16, the blind and disabled, or military on active duty - just be sure to have a current appropriate ID with you.

For all of these services, please stop by Elk Grove Township. We are located in our new building at 600 Landmeier Road in Elk Grove Village, right across the street from the Elk Grove Village Post Office. Welcome Shoppers!



Elk The Grove Food Township Pantry is offering Food Pantry visits twice per month to families of 4 or more. While the 'client choice' model has been very effective and allows shoppers to choose foods and toiletries they need most, often larger families are left with little to no food or

supplies by their next visit. With the option to shop twice per month, we ensure that families receive enough food with minimal food waste.

To ensure easy access to residents, Food Pantry registration is quick and simple. Residents need to provide a photo ID, a recent utility bill (issued within the past 30 days), and arrive 15 minutes before your appointment to have a food pantry card issued.

As the Food Pantry relies heavily on volunteers, who do a great job at sorting donations, stocking up shelves, packing groceries, and checking clients in and out of the food pantry, the Township would like to offer SPECIAL THANKS to all who help make the Food Pantry a great place for the residents.



Relationships

Peer relationships provide a unique context



in which children learn a range of critical socialemotional skills, such as empathy, cooperation, and

problem-solving strategies. Peer relationships can also contribute negatively to social-emotional development through bullying, exclusion, and deviant peer processes.

Emotional Regulation

Learning to self-regulate is a key milestone in child development – whose foundations are

laid in the earliest years of life. A child's capacity to regulate their emotions affects their family and peer, academic performance, long-term mental health, and their ability to thrive in a complex world.

Helping Your Child Identify Feelings



As children grow, we often think about the importance of their academic and social success. And, of course, we want them to be happy. But, we often

neglect to think about how they are developing their "emotional competence." This means, how well do they identify their feelings, express these feelings appropriately, understand the feelings of others, and modify their feelings or behavior based upon their interactions. During this pandemic, it's even more important to do "emotional check-ins" with your children. You see, children with "emotional competence" are much more likely to find success both academically and socially. Really.

So, how can we help our children to develop emotional competence?

1) First, help them identify and label feelings. They get angry, sad, embarrassed, happy, just like we do. But, if they do not have words to talk about how they feel, they often act out their feelings in inappropriate ways. So, use these words! For example, say "You seem sad that I have to leave for work." Or, "you were smiling, and seemed happy that you got so many birthday cards today."

2) Teach your child the different ways we deal with feelings, either by asking for their ideas, or sharing your own. For example, say, "you seem frustrated with

your homework, what can you do to push back against the frustration?" Or, "when I get frustrated, I take some deep breaths, and close my eyes for a few minutes."

3) Praise your child when s/he tries to talk about feelings. When s/he says, "I'm really mad that you won't let me have that cookie until after dinner," say, "thank you for sharing how you feel with me." (IMPORTANT: when your child is having a tantrum because they are not getting their way, it is best not to engage with them on this level).

4) Ask "perception of others" questions, such as, "what do you think Johnny was feeling when he was teased at school?" Or, "how can you tell when I am angry?"

In all, be a role model for identifying and expressing your feelings appropriately. Helping your children to do the same will leave them better equipped to lead successful lives. That will surely make you feel "happy."

Food Pantry Needs






