Assessing the Situation

As I write this, my staff and I sincerely hope that you and your families are well and that as spring approaches we will begin to appreciate more normal interactions. However, as of this mailing, we are still observing all the protocols necessary to keep us all healthy.

Property taxes are due to be paid by March 2, 2021, however, the deadline has been extended to May 3, 2021 without penalty.

Many of you have received notification that your exemptions have been automatically extended through this year. For those of you that receive notification that your exemptions have been dropped, please call our office for an appointment so that they may be reinstated. When you call, we will tell you what documentation you will need to bring with you.

Many of you have asked when will we be open for appeals to the Cook County Assessor's Office. We have not been informed when that will take place. When we are notified, we will let those on our email and phone lists know. If you would like to be included in that group, call 224-265-6110. You may also check our website for updates, www.elkgrovetownship.com.

Last year, we personally served over 3200 residential taxpayers and took or returned over 3300 phone calls that resulted in 13,000 Exemptions, Appeals and other assorted transactions being filed. Although I am always proud of the praise that goes to my staff from our taxpayers, this year I am humbled by their dedication, professionalism, and the positive attitude they have displayed during what could best be described as "battle conditions".

Thank you for your courtesy, civility, and friendship. It means so much to each of us. We have little idea of what 2021 will bring, however, I am confident we will meet if not exceed those challenges with your help.

BRANCH PICK-UP

Branch pick-up is offered in residential areas on the streets maintained by the Township ONLY (unincorporated areas) from April through October (weather permitting) on the 15th of each month. If the 15th falls on a holiday or weekend, branch pick-up will be scheduled for the following work day. The branch program is designed so that the township can help unincorporated residents keep their properties clean after storm damage. If property owners have extremely large amounts of brush, crews will only remove a portion of the brush.

We ask you to limit your piles to storm and wind damaged branches and not to exceed two cubic yards. If a landscaping or tree service takes down trees or branches on your property, they are responsible for its disposal. Please also remember your waste disposal company will pick up branches that are bundled and tied. Please do not begin stacking branches near the streets immediately after the township crews have finished in your area (16th of the month). Piling of branches after the pickup date creates an eyesore, causes damage to grassy areas, and invites animals, pests, mosquitos etc.

What will be picked up:

- Branches with a minimum 2' length, maximum 12' length and less than a 6" diameter.

What will NOT be picked up:

- Small hedge or pine clippings
- Yard waste or brush in containers
- Brush or branches with thorns
- Stumps or tree roots

How to stack the brush:

- Neatly stack the branches in one direction with the butt end toward the street
- No lumber, wire, rope, or other material may be included with branches
- Please do not place brush on another resident's property, if this happens please contact the Cook County Sherriff's office, not Elk Grove Township, as the township does not have authority in such matters
- Once we have gone through an area, we will not return until the next scheduled date

Emergency Assistance

Available to low income households who have experienced a hardship and have fallen behind in shelter or utility expenses

ComEd Hardship

Grant of up to \$500 towards past due balance for households at or below 250% of federal poverty level. Households must face hardship such as death in family, illness, criminal victim or job loss

LIHEAP- Low Income Home Energy Assistance Program

Yearly grants available to any household at or below 200% of Federal Poverty level towards Nicor and ComEd utilities

Lending Closet

No cost medical equipment rental such as walkers, wheelchairs, and grab bars among others

Nicor Sharing

Yearly grants of up to \$400 towards past due Nicor bill for households between 200% and 300% of federal poverty level

Mobile Dental Clinic

Screening for low cost dental care through Northwest Community Hospital for households at or below 200% of federal poverty level

Highway Department:

The role of the Highway Department is the care and maintenance of the roads in the unincorporated parts of Elk Grove Township. This includes repair and snow removal.

Transportation Services:

Bus Services : Senior residents of Elk Grove Township age 55 and older or 18+ with disability may use the township bus services. All buses are handicap accessible (i.e. walkers, wheelchairs, etc.).

T.R.I.P.: This program is the Northwest Suburban Cook County Inter-township Transportation for medical purposes for Senior Citizens and Persons with Disabilities.

Taxi Program: This program is our discounted taxi cab service. Seniors 55 and older and people with permanent disabilities over the age of 18 are eligible for taxi discount cards.

Bike Safety: Bicycle Safety is provided by Elk Grove Township to all grade school aged students of our Township. The program is funded by the taxpayers that live in our Township and has been in existence for almost 30 years.

Fostering Resilience during Uncertain Times

With the Coronavirus Pandemic, many people are experiencing anxiety, fear, depression, irritability, just to name a few! And it is difficult to know how to make it through with our emotional health intact, and relationships preserved.

Although this may be the first time we are personally experiencing a pandemic like this, we, as humans, were made to endure incredible things. Resilience allows us to bounce back from disasters, wars, heartbreak and significant loss. We are called upon to face disasters and need this reminder now more than ever.



Resilience is innate in the human spirit. It is a gift that we have within us. However, sometimes we need support to foster our strength and resilience. Resilience helps us to recover to our baseline, our normal state of functioning, even when we are faced with challenging times.



Shift the focus encourages you to start to pay attention to the signals you get from your body and internal response (inner voice). When we shift the focus from the outside stressor to our internal response, we can regulate our experiences, as well as support others to come back to a state of balance.



Regulate sleep patterns because sleep helps to regulate our body's natural rhythm, and specifically the release of cortisol (a stress hormone). When we are sleeping too much or too little, our natural biological rhythm gets thrown off balance. By maintaining a normal sleep schedule, we can keep our internal systems regulated and decrease feelings of worry and withdrawal.



We have a choice: We all have resilience in us, however, we must choose how to use it. Choosing resilience takes conscious effort. We must pay attention to our choices and bring our conscious mind into awareness. As we shift the focus back to our internal response, pay attention to what choices you are making.

HELPING TEENS MAKE GOOD DECISIONS



“I can’t believe that my 17 year old cut school yesterday knowing that she’d get in trouble”. Most parents have experienced situations when their teens make poor choices even though they know that a consequence will occur. So, why do teens make poor decisions at times? Teens brains aren’t fully developed yet and their impulses/emotions can get ahead of their controls, which means, they tend to act before thinking. Sometimes it helps to know that teens will make a lot of mistakes and a lot of bad decisions but these help them actually to become better decision makers. For example, a teen broke his phone or a teen spent their allowance on video games and they don’t have money to buy lunch that week.

Unfortunately, many parents miss these learning opportunities and may want to bail their teens out by buying them a new phone instead of the teen using their own money, working around the house as payment for the phone or even getting them a less expensive phone. One thing is certain, don’t run out immediately to buy another phone.

With regards to not having lunch money for the week, they may have to go without lunch that week or figure out how to make a lunch to take to school, either way the teen won’t starve missing lunch for a week. Parents need to step back and allow teens to make mistakes which helps them learn to deal with the natural consequences of those decisions, but also parents need to be there afterward to help them understand what went wrong with that decision and teach them how to make a better decision next time.

Allowing teens to learn to make good decisions allows them to live with and experience the pain of making bad decisions. As a parent this is one of the most difficult jobs you’ll have, but guiding teens towards making good decisions allows them to grow and become confident young adults.

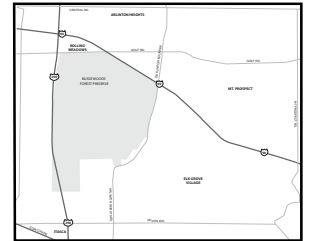

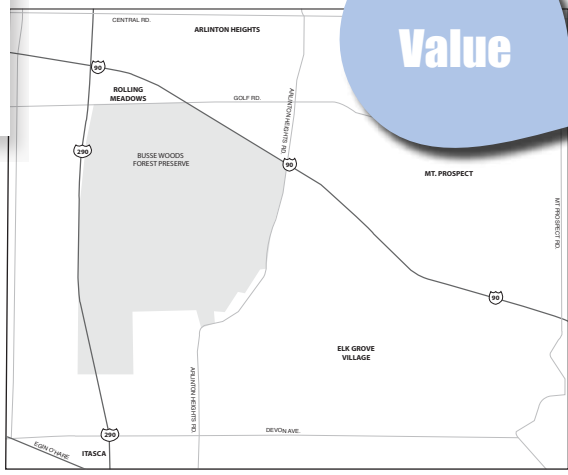
