## **ASSESSING THE SITUATION**

### **Governor Signs Property Tax Relief**

Recently signed legislation has finally brought property tax relief to our residents. Here are the changes that might affect your second installment property tax due and payable in 2018:

**Homeowners Exemption goes from \$7,000 to \$10,000 in EAV**

**Senior Exemption goes from \$5,000 to \$8,000 in EAV**

**Senior Freeze income level goes to \$65,000 from \$55,000 total household income**

**There is a new minimum \$2,000 EAV Deduction for the Senior Freeze, which will help offset increases in Assessed Value.**

### **Cook County Board of Review Appeals**

As this article is being written, we are accepting pre-file Appeals for the Cook County Board of Review. We anticipate being open for appeals with the Board in late September. Since this Newsletter will not be in your home until early October, check the Township website to find out when your window of opportunity will be to file an appeal.

**If you have the Senior Freeze Exemption, you do not need to file an Appeal!**

### **Money Smart Classes at the Township (October 17 & 19)**

about this very educational program that is being brought to you by the Mount Prospect State Bank and Elk Grove Township. Space is limited so please call today and make your reservations to attend.

The programs are a series of classes that will be held in Spanish and in English and will cover basic financial topics such as choosing and maintaining a check book, how to obtain and use loans effectively, and the basics of building and repairing credit. "Bank On It" will be the first class.

This class will explain the major types of insured financial institutions, the primary reasons for using a bank, describe the steps involved in opening a bank account, and several others. Participants will receive a take home guide that provides a summary of information provided in the class.

At that time, the Township Board will evaluate the viewership to see if there has been enough interest to warrant the continuation of the videotaping.

## **News from your Highway Commissioner**

### **Stormwater Management - How You Can Help**

(From MWRD Storm Water Management brochure for Cook County available at the Township Office)

Storm water management does not merely apply to flood control. It can also be used to improve water quality and conserve potable water. You can help out by implementing Best Management Practices at your residence. Example BMPs include rain barrels, cisterns, green roofs, rain gardens, permeable paving and natural landscaping. One simple measure is to disconnect your downspouts from the public storm sewer system. The storm water could be stored in rain barrels to be used to water gardens or directly discharged to rain gardens instead of flowing into our sewers. Reduction of storm water flow into our sewers reduces the amount of flow discharged into our waterways and can help to alleviate flood damages from occurring due to overbank flooding.

It is illegal to dump paint, oil, or any hazardous material into a street inlet as these materials will also pollute the waterway to which the storm sewer eventually discharges. Residents living near waterways should take extra care to remove debris on their property which could wind up in the waterway. Yard waste should be properly disposed of and not dumped into or along the banks of creeks or streams. Branches, bushes and other debris cause blockages at culverts and bridges which can cause flood damages for you and your neighbors. If you see anyone dumping garbage or any debris into a waterway, please call the MWRD at 1-800-332-DUMP.

# IMPORTANT Energy Bill Assistance: LIHEAP (Low Income Home Energy Assistance Program)

This past year, Elk Grove Township began to participate in new programs to help low income households with their energy bills. LIHEAP includes:

- **Direct Vendor Payment (DVP)/Reconnection Assistance (RA)**

DVP/RA is designed to assist income-eligible households with energy services, in the form of a one-time benefit payment to the utility companies that is applied directly to the household's energy bills. The amount of the payment is determined by income, household size, and fuel type. RA is used to prevent or reconnect disconnected households.

- **Furnace Assistance**

Furnace Assistance is designed to restore the home's heating system back to a safe and effective operation. Assistance is only available to approved households that have or are eligible to receive a LIHEAP benefit and whose heating systems are not operational or have been red-tagged by their utility company. The services are free of charge for income qualifying households. Renters are not eligible to apply. Program begins October 1st.

**Eligibility period is as follows:**

**October 1st**

Households with a senior member age 60+, households with a person receiving disability benefits. **Furnace Assistance begins.**

**November 1st**

Households with one or more disconnected utilities (or disconnect notice), or households with children age 5 and under.

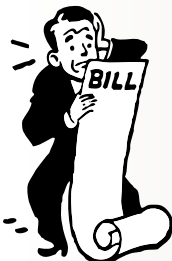
**December 1st**

All eligible households

**You may call to schedule an appointment for application ONE WEEK prior to your qualifying date. To do so, call 847-437-0300 and speak to our General Assistance office where we will be happy to pre-screen you, set up your appointment, and give you a list of documents necessary for application.**

## Gas Bill Relief



The Nicor Gas Sharing Program may be available to those over income for LIHEAP. The program offers a one-time annual grant (with **no** requirement to be paid back), to qualified residential customers who meet the required income guidelines. Nicor Sharing program is made possible through direct contributions from

Nicor Gas' customers and employees. If you're approved for a Sharing Grant, payments will be made to Nicor Gas on your behalf. Customers can receive a Sharing Grant of up to \$450 and special programs are designed for veterans and customers in crisis situations. **Free Weatherization Offering for Nicor Gas Sharing Customers-** Customers who are enrolled in the Sharing Program may be eligible for a free home assessment and free weatherization service through the Nicor Gas energySMART program. This offering includes a free home energy assessment, the installation of free energy-saving products, and free installation of weatherization upgrades including air sealing and insulation products. Improving the air sealing and insulation in your home improves comfort, reduces drafts and may lower your energy use and cost.

## From the Parenting Toolbox

From the Youth and Family Services Department

“My husband has a temper, and I’m worried about being safe in my own home.” Therapists in the Youth and Family Services Department hear this message from time to time. Sadly, domestic violence is around us, and is often hidden behind closed doors. Its secrecy is born of genuine fear, shame, guilt, and low self-esteem.

What is our response to a statement such as this? Of course, we want to support this person’s feelings and dignity, as they often feel ashamed, or have come to believe they are to blame. We also convey, clearly, that “safety trumps all other issues and you need to think of the physical and emotional safety of yourself and your kids.” We are also very fortunate in that we have community resources to recommend for beginning the process of ensuring safety, engaging legal advocacy (when necessary), and healing.

As many of you know, Elk Grove Township supports many worthy and important Not-for-Profit organizations (23 altogether). Among them are two that specifically support families experiencing domestic violence. These are, Life Span and Wings.

Life Span provides legal assistance, court advocacy and counseling for victims of domestic violence and sexual violence. They can assist with orders of protection, divorce and child custody, visitation, and other issues. They also provide individual and group counseling for adults and children. Services are FREE, and legal staff speak English, Spanish, Polish and Arabic. For more information, call (847) 824-0382.

Another community organization that assists families experiencing domestic violence is Wings. They offer emergency residential housing (safe shelter) and counseling. They also have a presence at local hospitals, offer trainings, and seek to “provide housing, integration services and advocacy to end violence.” For more information, call (847) 221-5680.

October is Domestic Violence Awareness Month. If you, a friend, or relative are concerned about safety within your homes, take the step to reach out to these wonderful community resources that help Elk Grove Township residents. **High cost of prescriptions got you down?**

Coast to Coast is a FREE program sponsored by Elk Grove Township and it's SIMPLE to use!

Here's how: Cut out the card below. Bring your prescription, along with the Coast to Coast card to the pharmacy of your choice. Ask the pharmacist to run your prescription through your current insurance and compare it to the cost using the Coast to Coast card (Your ID# is your phone number!) Choose to use whichever program costs you less--- It's really that simple!

Can't afford to see a doctor? No health insurance or stuck with a big deductible? **Access to Care has the answer!**

Since 1988, Access to Care has been helping individuals who are UNINSURED or HAVE HEALTH INSURANCE WITH HIGH DEDUCTIBLES, who live in suburban Cook County.

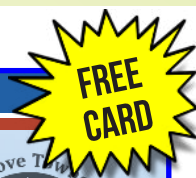

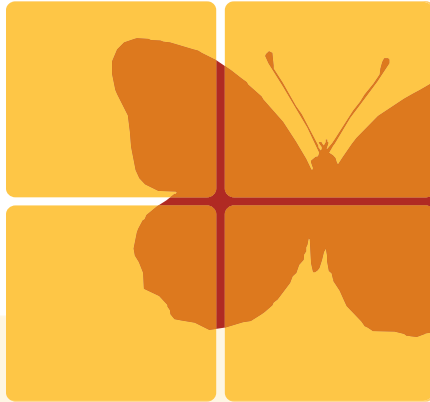
