- VI. Presentations
 - A. Alliant Insurance Services 2024 Property & Liability Insurance Proposal (Via Zoom) Michael Alesia shared that our premium for next year is increasing 22.45%. The causes of the increase include struggles in the cyber insurance market and the national property rate, increased property values and workman's compensation claims in 2020-2021 and 2022-2023. Also, there are a limited number of carriers in Cook County. The property insurance is for replacement cost of the property.
 - B. Mesirow Insurance Services Health Insurance Update for 2024 (Via Zoom) Juan Gomez de la Casa shared our premiums are going up 5.1% for the same three Blue Cross Blue Shield plans. Also, there is no change in Dental or Vision benefits. The plan automatically renews and any changes would need to be made by November 1.

VII. Reports:

- A. Assessor Assessor Carosielli provided a written report and an update on Board of Review opening, and mentioned that there will be an Outreach Program here tomorrow night at 6 pm, sponsored by our Assessor's Office. They also participated in the Senior Fair here last week.
- B. Clerk Clerk Satern provided a written report with one FOIA last month.
- C. Supervisor Administrator Pioch reported on the following updates, in the absence of Supervisor Busse.
 - 1. Northside projects the shelter is up, and furniture for the youth services offices is ordered.
 - 2. Senior Fair there were 30 booths and we had a very good turnout.
 - 3. Cereal Bowl Over 2,700 boxes of cereal were collected. Elk Grove High School was the winner. Rolling Meadows High School collected over 1,100 boxes which is more than they ever collect in the past.
 - 4. Passport Photo Machine it has been purchased and will be ready to use soon.
 - 5. LIHEAP the staff is going out to senior facilities to do applications.
 - 6. Shredding Event the event last Saturday in Mount Prospect went well.
