- I. <u>Call to Order</u> Trustee Keenley called the meeting to order at 7:00 pm, which was followed by the Pledge of Allegiance to the Flag.
- II. <u>Roll Call</u> Trustees Niewiardowski, Keenley, Maye and Perns. Others in attendance: Assessor Carosielli, Administrator Manzo, Financial Director Renz. Supervisor Busse joined the meeting by Zoom to give the Supervisor's Report only, not to vote.

- IV. Consent Agenda
 - A. Authorization for Payroll/Bills Town Fund, General Assistance, Road Dept. & Sewer
 - B. Supervisor Social Services, Employment Center, Food Pantry, Youth Services, Adult & Family Counseling, Transportation and Financial

A Motion to approve the Consent Agenda was made by Trustee Maye and seconded by Trustee Niewiardowski. *The Motion passed on a 4-0 roll call vote*.

- V. Discussion and Potential Action on Approval of Minutes
 - A. February 24, 2025 Regular Board Meeting Minutes

A Motion to approve the Minutes of the February 24, 2025 Board Meeting was made by Trustee Niewiardowski and seconded by Trustee Perns. *The Motion passed on a 4-0 roll call vote*.

- VII. Reports: Acceptance Of Township Elected Officials' Monthly Reports
 - A. Assessor Carioselli provided a written report and stated that she attended a Zoom meeting about exemption applications, and attended a Assessor's Conference where they discussed the bill proposing elimination of townships. Two Township Assessors from townships in Cook County were honored with awards at the conference.
 - B. Clerk Satern provided a written report with one FOIA request.
 - C. Supervisor Busse shared the following updates
 - 1. Food Pantry Lockers These lockers will have codes and will be located in the west entry vestibule. They will allow people who work during Food Pantry hours to get food when the pantry is closed. They will be installed by April 1.
 - 2. Legislation about Townships There are bills proposed to make it easier to eliminate townships. SB2217 was sent back to committee. SB2504 lowers the threshold of votes and allows county boards to initiate referendums to eliminate townships. It is extended until April 4.

Eliminating townships would cause services to be diluted, eliminated or changed. And there would be a higher cost for services without townships, and a miniscule amount of savings.

- 3. Ecolane Software The transportation software has been active since February 19, The software is making the dispatching of our buses more efficient, and making rides more accessible for our seniors. There were 800-900 riders this month, which is a large increase.
- 4. Youth Services District 59 has asked us to expand our Newcomers Program to another school. Supervisor Busse mentioned that the elected officials are welcome to go observe a Newcomers class.
- 5. Personnel We have hired two part-time employees in Youth Services. Danny LaRosa, a former caseworker, will be working 20-30 hours a week. Jennifer Solis, who has a Master's Degree in Public Health, will be working 10 hours a week. She replaces a previous part-time person. In Adult & Family Counseling we need to hire two part-time employees, one as a replacement and one for a new position. We are in the process of hiring a new part-time person for that department. We also have a part-time position open in the Food Pantry for volunteer coordination and food inventory.

- 7. Budget We will have a surplus of about \$200,000 that will go into reserves.
- 8. Township Accomplishments We have added new programs and expanded other programs as needed. The Board has done a great job in this area by responding to the changing needs of our residents.
