**ANNUAL TOWNSHIP TAX LEVY ORDINANCE**

An Ordinance levying taxes for the Elk Grove Township, Cook County, State of Illinois. for the tax year 2023, collectible in 2024.

In pursuance of authority vested in them by "an act in relation to Township Organization" approved March 4, 1874, as amended, the Board of Trustees in meeting assembled, to hereby find and declare that there will be required to be raised by general taxation the amounts herein after set down, to be levied upon all taxable property in said Township, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law, and the amounts so required are itemized and needed for uses and purposes as follows, to wit:

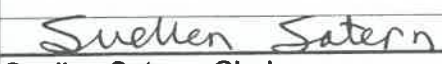
